Art 10 and Art 12 - Weebly - Background Information

- 1. Description of Weebly Weebly is a Web-Hosting service that allows individuals to create personal websites. Weebly has built-in templates that make creation simple and flexible, and Weebly includes a drag and drop feature that makes it easy to insert different types of media files including photos and text. As of August 2012, Weebly hosts over 20 million sites with a monthly rate of over 1 million visitors. Weebly is a free service, and it does not include any advertisements. Weebly is <u>located outside Canada</u> and within the jurisdiction of the United States, in San Francisco, so privacy issues need to be addressed.
- **2. Description of Activities** Students in Art 10 and Art 12 will be required to create an online ePortfolio of assigned art projects and independent work. The use of Weebly will encourage individualized learning and will encourage students to interact with each other online, in a positive way, and practice with a new medium than they may not have previously been exposed to, without the problems of distance and file size.

Specific examples include the following:

- Building an art ePortfolio with photographs of personal works
- Learning to comment on other students' work in a positive and appropriate manner
- Sharing real world and personal examples to support art activities
- Learning how to build a personal website
- Examining and learning proper use of websites and content
- **3. Possible Risks** There are risks involved in working online. Information is being shared in an open format, inside and outside Canada, and there is a possibility that students' online activities may be tracked. While the DL teacher will take every precaution to assure the safety of individual students, no online activity can be guaranteed 100% safe.

4. Weebly Privacy Points

- Weebly uses the information that users share with them for the sole purpose of running and improving their services.

- Students need to be aware to keep passwords private.
- Students need to be aware that they should report any concerns to their DL teacher.
- Students need to be aware that posting personal information, on an open site, may receive unsolicited messages and any information posted may be used by others.

- **6. On-line and Off-line Options** Weebly is a recommended, but optional, online tool. If you choose to withhold consent for your student to use Weebly, students will submit the required assignments directly to the course teacher. Alternate activities will be provided when necessary.
